## NAME AND AGE OF ALL QUALIFYING MEMBERS AS DEFINED BY THE CORPORATION:

I hereby make an application for membership to ZEBULON COUNTRY CLUB and understand that present membership and initiation fees are shown above and agree to pay amounts shown. I accept a one-year membership and must maintain my membership account in good standing, under the membership category I choose, for a period of no less than 12 consecutive months from the date my membership begins. I understand that monthly dues will be set by the Board of Directors of Zebulon Country Club and are due in advance. The Board may adjust fees at any time and will provide 60 days notification of such changes. The one-year membership commitment may be cancelled prior to the maturity date with a 30-day written resignation notice received by the club on the 5<sup>th</sup> of the previous month as long as the account is not delinquent and all charges for which I am liable is paid in full.

At the end of the 12-month agreement, membership will automatically renew on a month-to-month basis and no refunds will be given for partially used periods of dues or services. It is further understood and agreed that I will follow and adhere to all USGA rules **and** regulations as set forth by the Club. Any rule violations are subject to membership revocation without refund. *ZEBULON COUNTRY CLUB* does not assume responsibility for personal or private property damaged, lost, or stolen. I also assume full responsibility for golf carts and have a valid driver's license. <u>Anyone under the age of 16 must be</u> accompanied by an adult to use a golf cart.

Enclosed is a check, made payable to *ZEBULON COUNTRY CLUB*, or cash for the above amount. Such membership certificate shall entitle the holder thereof, and his/her immediate family to membership privileges which is nontransferable.

"Immediate family" shall not include any married child or any child that is not supported by said member. Membership privileges shall extend also to any child of a member who is still a bona fide student in a high school, college, or university, regardless of age, if said student is not married, is supported by said member and lives in the home of said member while attending school. Dependents reaching the stage where they no longer qualify as immediate family will be offered membership without initiation fee for a period of six months from date of disqualification.
